

# Bundaberg Animal Care Assistance Fund



## Bundaberg Greyhound Care Assistance Fund

The fund will provide financial assistance to Eligible Trainers who are unable to race locally in Bundaberg as a consequence of track modification works that will be undertaken from 1 August 2022.

Eligible Trainers will receive \$40 per week per Eligible Greyhound.

The fund will cease on the date of racing resuming at Bundaberg.

### Instructions

Please complete the form below to receive greyhound care assistance funding.

Claims must be for a minimum of four weeks and can only be made after the claim period has ended.

Claims of less than four weeks will be permitted if the greyhound is transferred during the claim period.

A new application form should be submitted for each claim period.

The final claim period may be less than four weeks.

### Who can apply for Greyhound Care Assistance Funding?

The applicant must be the Licensed Trainer responsible for the care of an Eligible Greyhound.

The applicant must reside in the Bundaberg Region to be an Eligible Trainer.

The Bundaberg Region is defined as Gympie (post code area 4570) to Seventeen Seventy (post code area 4677).

### What is an Eligible Greyhound?

An eligible greyhound must meet the following criteria:

- a) Was in the care of the Eligible Trainer for the period of claim; and
- b) Had raced at Bundaberg at least once between April 1, 2022, and July 25, 2022, inclusive whilst in the care of the Eligible Trainer.

Unraced greyhounds and retired greyhounds are not eligible.
