

ORDER OF ENTRY

1. Priority entry:
 - Group 1 winner last 9 months
 - Group 2 winner last 9 months
 - Group 3 winner last 9 months

2. One or more of the following:
 - Grade 1 track/distance
 - Grade 2 track/distance
 - Group 1 placegetter last 9 months
 - 2 or more Group 1 finals last 9 months
 - 2 or more Group placings last 9 months
 - 3 or more Group finals last 9 months

3. Two or more of the following:
 - Grade 3 track/distance
 - Grade 4 track/distance
 - G1 finalist since last 9 months
 - Group placegetter last 9 months
 - 2 or more Group finals last 9 months
 - 3 or more Group and Listed finals last 9 months
 - Listed winner last 9 months
 - Class 1 Feature winner at the track/distance last 9 months

4. Two or more of the following:
 - Grade 3 track/distance
 - Grade 4 track/distance
 - Group finalist last 9 months
 - 2 or more Group and Listed finals last 9 months
 - Listed placegetter last 9 months
 - Class 1 Feature placegetter at the track/distance last 9 months
 - Group 3R winner last 9 months
 - Class 1 winner last 9 months

5. One or more of the following:
 - Grade 3 track/distance
 - Grade 4 track/distance
 - Group finalist last 9 months
 - Listed finalist last 9 months
 - Class 1 Feature finalist at the track/distance last 9 months
 - Group 3R placegetter last 9 months
 - Class 1 winner last 9 months

6. Grade 5 track/distance

TERMS AND CONDITIONS

- The Selection Panel will determine the ballot order using the Order of Entry.
- The Order of Entry has six levels. Within each level, the Class 1 Order of Entry for Graded Events (as per RQ Grading Procedures) may be used to approximate the ballot order.
- At each level greyhounds with more qualifying performances may be elevated above greyhounds with less qualifying performances in the Ballot Order.
- The composition of the heats will be determined by the Field Selection Method prescribed below.
- All references to grade and class in the Order of Entry are relative to the RQ Grading Procedures.
- As per Local Rule 34A, a trainer must submit a statutory declaration in the form prescribed below to the Queensland Racing Integrity Commission before nominating greyhounds in Queensland.

FIELD SELECTION METHOD

- The top 25% of starting runners will be seeded.
- The remaining 75% will be randomly drawn.
- Greyhounds will be guarded as per Racing Queensland Grading Procedures.
- The Selection Panel will determine the seeds using the Order of Entry and aged prizemoney as a guide. Aged prizemoney is defined in the table below.
- The seeds will be distributed evenly amongst the heats approximately having regard for guarding.

0-30 days ago,	100% of the value of the prizemoney is counted
31-60 days ago,	80% of the value of the prizemoney is counted
61-120 days ago,	60% of the value of the prizemoney is counted
121-180 days ago,	40% of the value of the prizemoney is counted
181-360 days ago,	20% of the value of the prizemoney is counted
361-540 days ago,	2% of the value of the prizemoney is counted
541 days plus	1% of the value of the prizemoney is counted
Total	The total aged prizemoney is the sum of the values above

DISCRETIONARY POWERS

- If in the opinion of the Selection Panel the race form credentials of a greyhound overwhelmingly justifies a starting position in the heats, the Selection Panel may use discretionary powers to elevate the greyhound in the Ballot Order.
- The Selection Panel is not bound to elevate any greyhounds.
- The decisions of the Selection Panel, including discretionary decisions, as to the composition of the fields will be considered final.
